South Sydney Regional Council Annual Report 2009

(A report from the South Sydney Regional Council.)

Introduction

1. The Council met on six occasions during 2009. The dominant question before the Council during the year was how to cope with what was expected to be severely reduced financial resources.

Membership

At the November meeting, Archdeacon Deryck Howell was thanked for his significant contribution to the region, before leaving to take up his position at Rosemeadow.

Regional Council Planning Day

3 On Saturday 23 May the Council met at Bishopscourt to consider the role and responsibility of Council, particularly in the light of reduced funding as a result of the possible severe cutback in available funds due to the losses in the Diocesan Endowment. Consideration was given as to the best use of resources and hopes and aspirations for the region. There was also discussion on priorities and strategies that might be adopted in the coming years.

Property Issues

- 4. Council welcomed the news that the DA for the new building at Broadway had been passed, and that the building should be completed in 2011. The development at Annandale was completed during the year with the new building being opened on 29 September.
- 5. There was also discussion on the proposed developments at Green Square and Pyrmont and reports received on a number of

building issues in the Parish of South Sydney related to the indigenous ministry.

7. Because of the 50% drop in funding from the Synod, it was agreed that there would be no new grant applications in 2010 but that existing agreements be honoured as they wound down. Parish partnership grants had been given on an agreed declining amount for a fixed term. As the university chaplaincy money was to be distributed by

a new Tertiary Ministry Oversight Committee it was agreed to cease these at the end of 2009.

- 8. Support for the ministry at Lord Howe Island would be maintained at \$13,000 p.a. but the Mission Board would be asked if it might become the responsibility of the whole Synod.
- 9. The Regional Council allocated \$5,000 to support Sauerkraut, the special clergy church leadership training program run by Bishop Forsyth.

Other Matters

Ministry Partnerships.

10. It was reported that a number of new initiatives had occurred in the region. Centennial Park and Bondi were working together with Warwick de Jersey as acting rector and Matt King as assistant minister located at Bondi. A similar partnership was being explored with Clovelly when Lindsay Johnstone retires with Dave Rogers starting an evening congregation at Clovelly.

Associated Congregation

11. Council received notification that under the terms of the Parish Administration Ordinance 2008 para 5(2) (b) the Parish of Newtown with Erskineville would be commencing a congregation in the grounds of the Sexton's Cottage. Council approved this request.

Indigenous ministry and South Sydney parish

12. The Council established a task force to work with South Sydney parish on a number of property matters, including the house owned by the Council for an indigenous worker. A second task force was established to work with the Sydney Anglican Indigenous Peoples' Ministry Committee on restructuring the indigenous ministry in the region in 2010.
