Standing Committee noted that on 6 December 2013 the NSW Government extended the first transitional compliance period for Working with Children Check clearances, including for licensed clergy and lay ministers, from 31 December 2013 to 31 March 2014.

(a) indicated a general expectation that all members of the Standing Committee should be willing to serve on one or more of its subcommittees, and

- (b) requested that during the process of nominating persons for appointment or election as members of the Standing Committee, consideration be given to ensuring that the membership of the Standing Committee retains an appropriate number of persons with the relevant skills and experience for service on its permanent subcommittees, and
- (c) expressed a desire to make greater use of its subcommittees, particularly in the exercise of the Standing Committee's functions under executive delegations where possible and appropriate.

Amend terms of reference

Standing Committee agreed to amend the terms of reference of the Finance Committee to provide that -

- (a) a meeting quorum requires at least one Standing Committee member, and

- (a) exercise the executive delegations previously exercised by the Mission Board in respect to payments made from the Mission Areas Fund, and
- (b) exercise the executive delegations which are exercised by the Ordination Training Fund Committee in respect to payments made from the Ordination Training Fund,

and agreed that the Ordination Training Fund Committee be discontinued.

Minute Reading Committee

Standing Committee requested that the minutes of Standing Committee meetings be posted on SDS's secure website in draft form as soon as the relevant minute reader has indicated to the Diocesan Secretary satisfaction with the draft minutes (rather than after the minutes have been signed).

Stipends and Allowances Committee

Standing Committee agreed –

- (a) that the membership of the Stipends and Allowances Committee should be expressed to include at least one clergy wife but that clergy spouses should be treated as clergy for the purposes of the current requirement that a majority of members of the Committee be lay persons, and
- (b) for the purpose of transition the membership of the Stipends and Allowances Committee should remain unchanged until elections are held for this subcommittee at the Standing Committee meeting in November 2014.

General Synod Canons and Consultation

Standing Committee agreed that -

- (a) the General Synod Consultation Group should be merged with the General Synod Canons Committee to form a "General Synod Relations Committee" with the existing terms of reference of the General Synod Canons Committee modified accordingly, and
- (b) for the purpose of transition, the membership of the General Synod Relations Committee should comprise the existing members of both General Synod Canons Committee and the General Synod Consultation Group until elections are held for this subcommittee at the Standing Committee meeting in November 2014.

Public Policy

Standing Committee -

(a) agreed that the committee constituted by the Standing Committee in April 2009 to consider human rights, religious freedom and anti-discrimination law reform comprising Bishop Robert Forsyth (chair), Dr Robert Tong AM, Dr Karin Sowada and Mr Robert Wicks be treated as a permanent subcommittee of the Standing Committee with the appointment by the Archbishop of an additional member who shall have formal theological training, and (b) requested the subcommittee to prepare and recommend to the Standing Committee suitable terms of reference for the subcommittee and comment on whether "Public Policy Reference Group" would be an appropriate name for the subcommittee.

Service Review

Standing Committee -

- (a) agreed that the committee constituted by the Standing Committee in August 2011 to review the services provided by SDS to the Synod and the Standing Committee on a yearly and half-yearly basis comprising Mr Peter Evans (chair), Dr Claire Smith and the Rev Chris Moroney be treated as a permanent subcommittee of the Standing Committee, and
- (b) requested the subcommittee to prepare and recommend to the Standing Committee suitable terms of reference for the subcommittee and comment on whether "Service Review Committee" would be an appropriate name for the subcommittee.

Royal Commission Steering Committee

Standing Committee agreed that the Royal Commission Steering Committee constituted by the Standing Committee in December 2012 to oversee the response of the Diocese to the Royal Commission and to provide the Director of Professional Standards with a point of reference for undertaking the necessary work to respond to the Royal Commission comprising Mr Doug Marr, Mr Lachlan Bryant, Dr Robert Tong AM, Mr Russell Powell, the Rev Dr Andrew Ford, Mr Steve Lucas, the Rev Craig Roberts, Dr David Nockles and the Rev Zac Veron with power to co-opt, be treated as a permanent subcommittee of the Standing Committee.

Review of Terms of Reference of permanent subcommittees

Standing Committee requested each of its permanent subcommittees to review their terms of reference and bring back to the Standing Committee by August 2014 any recommendations for change.

Church Planting Task Force

Standing Committee agreed that for the time being the Church Planting Task Force be regarded as an ad hoc subcommittee of the Standing Committee.

Support of ad hoc subcommittees

Standing Committee agreed that, unless an ad hoc subcommittee indicates that it does not require any secretarial support from SDS, an amount of \$1,500 be paid from Contingencies to SDS upon the establishment of any ad hoc subcommittee by the Standing Committee.

Use of supplementary agendas

Standing Committee requested the Diocesan Secretary to draft for its consideration regulations for the use of supplementary agendas which include limiting the use of supplementary agendas to –

- (a) material arising directly from items of business on the main agenda, and
- (b) new items of business if they have to be dealt with at the meeting as a matter of urgency.
