Minutes of Proceedings of the Synod for Tuesday 4 May 2021

Preliminary

1. Assembly

The Synod assembled in the Darling Harbour Theatre, International Convention Centre at 4.30 pm.

2. Prayers

Mr Michael Duckett led the Synod in a prayer of acknowledgement of country.

Prayers were led by the Acting Registrar, Mr Tony Willis.

3. Bible Study

Mr Daniel Glynn moved -

'Synod suspends so many of the Standing Orders as would prevent the person(s) appointed by the President to read a passage from the Bible and apply it, at a time determined by the President, on this and subsequent days of this session.'

Seconded and carried

Canon Simon Manchester led the Synod in a Bible Study from Ezekiel 11:14-25.

4. Lists of members of the Synod

The President tabled the lists of clergy and lay representatives summoned to the Synod.

5. Presidential Address

Mr Daniel Glynn moved -

'Synod suspends so many of the Standing Orders as would prevent the President giving his address to the Synod at a time of his choosing.'

- (ii) recognising that such exclusion seeks to create an environment in which Synod members can engage in free and frank discussion for the purpose of electing the next Archbishop,

requests that, unless permission is given by the President, members of the Synod -

- (a) not use social media to convey an account of the proceedings of the Synod to or discuss the proceedings with any member of the public (including the media) during the period between the conclusion of the Presidential Address today and the end of the session on a subsequent day, and
- (b) not audibly or visually record any part of the proceedings of the session,

and requests further that Synod members exercise general discretion in what they convey or discuss about the proceedings of the Synod by other means during or subsequent to the session.'

Final Choice of a Nominee

10. The Very Rev Kanishka Raffel – Invitation to become Archbishop of Sydney

The President moved -

"That the Very Rev Kanishka Raffel be invited to become Archbishop of Sydney."

A vote on the motion was taken by show of hands in each order.

The majority of the house of laity, present and voting, voted in favour of the motion, with 362 votes for and nil votes against.

The majority of the house of clergy, present and voting, voted in favour of the motion, with 205 votes for and nil against.

There having been a unanimity of members voting in favour of the motion, the President declared the Very Rev Kanishka Raffel to have been duly elected to the Office of Archbishop of Sydney.

Members of the Synod stood and applauded.

The Very Rev Kanishka Raffel and Mrs Cailey Raffel entered the Synod meeting hall. Dean Raffel addressed the Synod commencing with a reading from 1 Corinthians 3 and led the Synod in prayer.
