AN ORDINANCE to make provision for the acquisition of furniture and effects for use in the residence referred to in The Bishop Coadjutor's Residence Ordinance 1956 and further to vary the trusts of certain Church properties mentioned in such Ordinance; to amend such Ordinance and for purposes connected therewith.

WHEREAS:

1. In pursuance of sub-clause (a) of Clause 2 of The Bishop Coadjutor's Residence Ordinance 1956 (herein called "the Principal Ordinance") the Corporate Trustees therein referred to have agreed to purchase a suitable residence for the use of a third Bishop Coadjutor or otherwise as therein mentioned.

2. It is expedient to provide furniture and effects for use in the said residence.

3. It is expedient further to vary the trusts mentioned in the Principal Ordinance.

Now the Standing Committee of the Synod of the Diocese of Sydney in the name and in the place of the said Synod ordains and declares as follows:

1. By reason of circumstances subsequent to the creation of the trusts to which the Bishop's portion of the Moore Bank Estate and Bishopscourt are respectively subject it has become inexpedient to carry out or observe such trusts so far as the same are inconsistent with the provisions of this Ordinance.

2. Clause 2 of the Principal Ordinance is amended—

(a) by omitting sub-clauses (b) and (c);

(b) by omitting from sub-clause (d) the words "or built."

3. After Clause 2 of the Principal Ordinance the following Clause is inserted—

The Bishop Coadjutor's Residence Ordinance No. 2 1956.

"2A. The Corporate Trustees are hereby authorised and directed from time to time—

- (a) to acquire furniture and effects for use in the said residence;
- (b) to repair maintain or renew all or any of such furniture and effects;
- (c) to sell all or any of such furniture and effects and apply the proceeds of sale in pursuance of this Ordinance.

Provided that the total of the amount or amounts expended under this clause (after deducting any proceeds of sale) shall not exceed One thousand pounds (£1,000) or such other sum as the said Standing Committee may from time to time determine."

4. Clause 3 of the Principal Ordinance is amended by omitting the word and figure "Clause 2" and inserting in their stead the words and figures "Clauses 2 and 2A."

5. Clause 4 of the Principal Ordinance is amended—

- (a) by omitting the words "erected or";
- (b) by inserting after the word "stands" the words "and the said furniture and effects."

6. This Ordinance may be cited as "The Bishop Coadjutor's Residence Ordinance No. 2 1956" and shall be read and construed with the Principal Ordinance.
