## AN ORDINANCE to amend The Car Finance Board Ordinance 1952-1965

WHEREAS it is desired to extend the provisions of the Car Finance Board Ordinance 1952-1965 for the benefit of other Dioceses in the Province of N.S.W. subject to certain conditions, to empower The Board to act as an insurance broker and to amend the name of the said Board NOW the Standing Committee of the Synod of the Diocese of Sydney in pursuance of the powers delegated to it by Church of England (Bodies Corporate) Act 1938 Delegation of Powers Ordinance 1961 HEREBY ORDAINS DIRECTS AND RULES as follows:-

1. The Car Finance Board Ordinance 1952-1965 is in this Ordinance referred to as "the Principal Ordinance."

2. This Ordinance may be cited as "The Car Finance Board Ordinance Amendment Ordinance 1966."

3. The Principal Ordinance as amended by this Ordinance may be cited as "The Sydney Diocesan Car Finance and Insurance Board Ordinance 1952-1966."

4. Clause 1 of the Principal Ordinance is amended by inserting the words "Sydney Diocesan" after the word "the" in line 1 and by inserting the words "and Insurance" after the word "Finance."

5. Clause 5 of the Principal Ordinance is amended by inserting the following sub-clause:-

(e) Acting as an insurance broker or agent in respect of all types of insurance.

6. By inserting the following new clause as clause 8A after clause 8:-

- "8A. The Board may consider and at its discretion make advances for assisting Clergy, officers of Parishes and official organisations of any Diocese in the Province of N.S.W. to acquire motor vehicles either upon hirepurchase or otherwise subject to the following conditions:-
  - (i) all applications shall be approved by the Bishop of the Diocese concerned except in the case of the Diocese of Sydney.
  - (ii) the responsibility for any bad debts shall be assumed by the Diocese in which the applicant at

the time of application resides except in the case of the Diocese of Sydney.

- (iii) The comprehensive insurance covering vehicles on which loans are granted shall be arranged through the agency of the Board.
- (iv) That the first priority for advances as may become available be in favour of applicants in the Diocese of Sydney and thereafter in order of date of receipt or in such other order as the Board may think fit.
