THE CHRIST CHURCH ST. LAWRENCE SYDNEY RESUMPTIONS ORDINANCES AMENDING ORDINANCE 1976

No. 48 1976

AN ORDINANCE to vary the trusts on which certain property is held.

WHEREAS

- By Clause 3 of The Christ Church St. Lawrence Sydney Church Rectory and School Ordinance 1932 as amended by Clause 2 of The Christ Church St. Lawrence Sydney Church Rectory and School Ordinance 1932 Amendment Ordinance 1935, Church of England Property Trust Diocese of Sydney (hereinafter called the "Corporate Trustee") was directed to hold certain property (hereinafter called the "School Compensation Money") upon the trusts set forth in that clause as amended. By Clause 6 of The Christ Church St. Lawrence Sydney Church Rectory and School Ordinance 1932 Amendment Ordinance 1935 as modified by Clause 2 of The Hostel for University Students Ordinance 1950, the Corporate Trustee was directed to apply parts of the balance of the school compensation money for the provision of a hostel for university students to be carried on under the constitution approved by Ordinance of Synod (and for this purpose was directed to set aside the sum of Fifteen thousand pounds (£15,000) and to apply the same as and when the Standing Committee of the Synod by resolution should direct in accordance with that clause as amended) and in or towards the further establishment ' financially of the Moss Vale Branch of the Sydney Church of England Girls' Grammar School at such times in such amounts and in such manner as the Standing Committee by resolution with power to vary the same shall from time to time direct.
 - C. The Corporate Trustee has made a provision for a hostel for university students in accordance with the said provisions.
- 25 D. The Moss Vale Branch of the Sydney Church of England Girls' Grammar School has closed.

- E. It is expedient that the trusts on which the balance of the school compensation money is held be varied to the extent hereinafter provided.

 NOW the Standing Committee in the name and place of the Synod of the Diocese of Sydney HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:—

 1. (1) By reason of circumstances subsequent to the creation of the trusts on which the school compensation money is held it has become inexpedient to carry out and observe the same to the extent to which the same are hereby varied.
- (2) The whole of the balance of the school compensation money held by the Corporate Trustee shall be held upon the same trusts as the trusts on which the property described as the "trust fund" in the Sydney Church of England Girls' Grammar School Assistance Ordinance 1974 1976 is held.
- 2. This Ordinance may be cited as "The Christ Church St. Lawrence Sydney Resumptions Ordinances Amending Ordinance 1976".
