## No. 33, 1964.

AN ORDINANCE to authorise the incorporation of "The Council for the Promotion of Sydney Church of England Diocesan Schools" as a body corporate pursuant to the provisions of the Church of England (Bodies Corporate) Act 1938.

WHEREAS by "The Council for the Promotion of Sydney Church of England Diocesan Schools Ordinance 1947-1961" the Synod of the Diocese of Sydney constituted The Council for the Promotion of Sydney Church of England Diocesan Schools for the purpose of controlling managing and carrying on the Schools set forth in the Schedule thereto and with power to promote acquire and establish other schools and control manage and carry on the same and make such arrangements financial or otherwise for the benefit development extension and improvement of all its Schools and the assets thereto belonging and generally order and conduct the affairs of the same as the Council might from time to time think fit provided that any syllabus of Religious Instruction should be approved by the Board of Education of the Diocese of Sydney AND WHEREAS by the Church of England (Bodies Corporate) Act 1938 Delegation of Powers Ordinance 1961 the Synod of the Diocese of Sydney appointed the Standing Committee of such Synod cs the Committee to exercise from time to time during the recess of such Synod certain powers authorities duties and functions of Synod conferred upon it by the said Act including the constitution of a body corporate in pursuance of Section 4 of the said Act AND WHEREAS it is expedient that The Council for the Promotion of Sydney Church of England Diocesan Schools as constituted by the said Ordinance should be constituted a body corporate as provided by the said Act NOW the Standing Committee of the Synod of the Diocese of Sydney HEREBY ORDAINS DIRECTS AND RULES as follows:-

1. The Standing Committee of the Synod of the Diocese of Sydney hereby declares that it is expedient for the purpose of controlling managing governing and carrying on the Schools now or hereafter to be controlled managed governed and carried on pursuant to the provisions of "The Council for the Promotion of Sydney Church of England Schools Ordinance 1947-1961" as institutions or organisations of the Church of England in the Diocese of Sydney that the persons who for the time being are mombers of The Council for the Promotion of Sydney Church of England The Council for the Promotion of Sydney Church of England Diocesan Schools Incorporation Ordinance 1964

Diocesan Schools shall be constituted a body corporate under the name of "The Council for the Promotion of Sydney Church of England Diocesan Schools."

2. This Ordinance may be cited as "The Council for the Promotion of Sydney Church of England Diocesan Schools Incorporation Ordinance 1964."
