Diocesan Organisations (Certain retirements related to the second ordinary session of the 52nd Synod) Ordinance 2021

No 44, 2021

Long Title

An Ordinance to set a new retirement date for members of certain boards and councils of Diocesan organisations whose membership was due to expire at or following the second ordinary session of the 52nd Synod.

Preamble

A. There are 28 positions on the boards or councils of Diocesan organisations that were expected to fall vacant following the second ordinary session of the 52nd Synod that was scheduled to commence on 6 September 2021 but has been postponed to a later date in 2022 owing to the COVID-19 pandemic.

B. At its meeting on 9 August 2021, to provide for an orderly succession and to provide certainty to organisations, the Standing Committee requested that a suitable form of ordinance be prepared and promoted to a future meeting of the Standing Committee to give effect to a new retirement date of these positions and to enable the election and appointment of new members to proceed independently of the second ordinary session of the 52nd Synod.

C. The Ordinance also sets a new retirement date for positions that were expected to fall vacant at the second ordinary session of the 52nd Synod and which are filled by appointment of the Archbishop.

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows.

1. Name

This Ordinance is the Diocesan Organisation (Certain retirements related to the second ordinary session of the 52nd Synod) Ordinance 2021.

2. New retirement dates

(1) This clause applies notwithstanding and to the exclusion of any provision to the contrary in the constituting ordinance of a body listed in Schedule 1 and Schedule 2.

(2) A person who is to retire from office as a member of a body listed in Schedule 1 at the first meeting of the Standing Committee next following the second ordinary session of the 52nd Synod is to instead retire at the first meeting of the Standing Committee in 2022.

(3) A person who is to retire from office as a member of a body listed in Schedule 2 at the second ordinary session of the Synod, who has been appointed to that office by the Archbishop, is to instead retire at the first meeting of the Standing Committee in 2022.
