The amendments made by clause 1 hereof shall take effect on a date to be fixed by the Metropolitan being a date after the date on which the Metropolitan shall have certified to the effict that this Ordinance, having been passed by the Provincial Sypod, has been assented to by all of the several dioceses in the Prevince and that the amendments made by clause 1 hereof have been ratified by Canon of the General Synod of the Church.

3. The Provincial Synod Constitution Ordinance 1907-1970 as amended by this Ordinance applies to and in retail on to the first session of the Provincial Synod held not less than fifteen (15)

4. If a session of the Provincial Synod is held within fifteen (15) months after the date fixed by the Metropolitan under clause 2 hereof the Provincial Synod Constitution Ordinance 1907-1970 as in fixed immediately before that date shall notwithstanding the amendments made by clause 1 of this Ordinance apply to and in relation to that session of Provincial Synod.

5. The Amendments made by clause 1 hereof shall not operate to terminate the appointments of the persons who held offices as representatives of a diocese immediately before the date fixed by the Metropolitan under clause 2 except in respect of a session of the Provincial Synod to be held not less than fifteen (15) months after the date so fixed.

6. This Ordinance may be cited as "The Provincial Synod Constitution Ordinance of 1907 Amending Ordinance 1984".
