

The Barker College Ordinance 1978 Amendment Ordinance 2019

No 14, 2019

Long Title

An Ordinance to amend the Barker College Ordinance 1978.

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows.

1. Name

This Ordinance is the Barker College Ordinance 1978 Amendment Ordinance 2019.

2. Amendment

The Barker College Ordinance 1978 is amended as follows -

- (a) delete the word 'Headmaster' in the Table of Provisions and insert instead the word 'Head',
- (b) delete the matter 'School Chapels and Chaplains Ordinance 1975' in clause 3(4) and insert instead the matter 'Anglican Schools Ministry Ordinance 2016',
- (c) delete clause 5,
- (d) delete clause 7 and insert instead the following –
 - 7. Synod Members: Retirement and Term of Office etc**
 - (1) At the first and second ordinary session of each Synod, three of the persons who are members elected by the Synod for the time being are to retire from office. At the third ordinary session of each Synod, two of the persons who are elected by the Synod for the time being are to retire from office.
 - (2) The members who are to retire are those members who have been in office longest since their last election. As between persons who were elected as members on the same day, those to retire (unless they otherwise agree among themselves) are to be determined by lot.
- (e) amend clause 8 as follows –
 - (i) delete subclause 8(1),
 - (ii) delete the matter "subclause (1) of this clause and" in subclause 8(2),
 - (iii) delete subclause 8(3), and
 - (iv) renumber the remaining subclauses in clause 8 as subclauses (1) and (2) respectively.
- (f) amend clause 9 as follows –
 - (i) delete subclauses 9(1) and 9(2), and
 - (ii) delete the matter "(3)" at the beginning of the remaining text,
- (g) amend clause 16 as follows -
 - (i) delete the word 'Headmaster' from the Title and insert instead the word 'Head', and
 - (ii) delete the words 'Headmaster, Headmistress or other principal teacher' and insert instead the word 'Head',
- (h) delete all the matter in clause 17 and insert instead the following –
 - 17. Appointment of Chaplain**
 - With the approval of the Head, the Council must appoint an ordained person as the Chaplain, who holds a licence from the Archbishop and whose duties are set out in the Anglican Schools Ministry Ordinance 2016.
