Parishes (Special Administration) Ordinance 2004

(A report from the Standing Committee.)

Background

- 1. In 2004 the Synod passed the Parishes (Special Administration) Ordinance 2004 (the "Ordinance"). Clause 8 of the Ordinance requires the Standing Committee to bring a report to the Synod in 2007 about the operation of the Ordinance.
- 2. The Ordinance enables special administrative arrangements to be adopted by a parish. These arrangements modify the existing administrative arrangements that currently apply under the Church Administration Ordinance 1990.
- 3. In essence the arrangements, if adopted, enable a parish to move away from using churches (ie buildings licensed for divine service) as the basic unit through which the parish is administered. Instead the arrangements formally recognise the congregations of the parish as the means by which the parish can be administered as a whole.
- 4. For this purpose, the Ordinance provides for -
 - (a) "parish meetings" (and "annual parish meetings") of members of all congregations of the parish being held instead of vestry meetings and annual vestry meetings for each church of the parish,
 - (b) the annual parish meeting deciding whether or not there should be a representative on the parish council for each congregation,
 - (c) 3 "parish wardens" for the parish as a whole instead of 3 churchwardens for each church of the parish, and
 - (d) the parish wardens exercising charge, control and administration over property, maintaining accounts and preparing financial statements for the parish as a whole.

Adoption of special arrangements by parishes

- 5. There have been 31 parishes that have adopted the special arrangements. The Registrar has also received notification of 14 new congregations across 11 parishes under the special arrangements. See the attached tables for further details.
- 6. In view of the relatively low number of congregations notified under the arrangements, it is likely that not all congregations that should be notified have been notified. A possible explanation for this is that parishes, having adopted the special arrangements, may be under the misapprehension that there is no need to notify congregations.

Feedback from parishes

- 7. Those parishes that had adopted special administration were contacted to obtain their feedback. Rectors were asked four questions
 - (a) Why did the parish choose to adopt special administration?
 - (b) Has the parish experienced any problems, either in the adoption of the special administration or since adoption?
 - (c) What were the principal benefits arising from the adoption of special administration for the parish?
 - (d) Any suggestions for the improvement of the operation of the Ordinance.
- 8. Feedback was received from 13 parishes.
- 9. The most common reasons for adopting special administration were as follows
 - a desire for streamlining the number of parish councils and church wardens,
 - the need to unify the parish by being able to enable congregations in alternative locations to vote at vestry meetings, or sit on Parish Council, and
 - amalgamation with another parish due to small sizes.
- 10. The general response to the Ordinance was extremely positive, with eleven parishes saying that they had not experienced any problems. The only negative comments related to perceptions by parishioners in two parishes that they might be 'losing their say'. It was felt that parishioners did not

necessarily understand the reasons why the parish would be better positioned for ministry having adopted special administration.

- 11. The most frequently repeated benefit was flexibility. Other benefits included
 - unity in one case, a parish found that the adoption of special administration fitted in well
 with the ethos they were trying to develop of unity in the case of a church plant and the
 "mother church".
 - efficient and centralised administrative structure in terms of annual parish meetings and wardens.
- 12. One parish indicated as a benefit that the special arrangements enabled parishioners from an "amalgamated church" to participate fully in church life immediately (ie. voting at vestry meeting) rather than waiting 3 months. It is possible that such a comment reflects a slight confusion of the special administration arrangements with the provisions for associated congregations under part 7 of the Church Administration Ordinance 1990.
- 13. The majority of rectors did not have any suggestions for improvement. However, the following comments were received
 - in the case of having multiple locations, a great deal of pressure was put on 3 wardens, and it might have been easier if the parish could appoint more wardens,
 - a leaflet to hand out to parishioners detailing the purpose and benefits of the Ordinance might be useful in convincing parishioners of the need to adopt special administration (although one rector noted the clear information available on the website which he used as the basis for creating a handout for parishioners), and
 - the difficulty of managing a vestry meeting due to increased size
- 14. Overall, every parish contacted noted the benefits that had come with their adoption of Special Administration, and all were very positive about their experience with the adoption and continuation under Special Administration.
