

Activities

7. The Regional Council has continued to give time and attention to the ministry strategy being developed for the parishes from Marrickville to Bankstown. A special report was commissioned from Rev C Thanopoulos and Mr N Hadges on the Marrickville area and financial support was made available to support the parish of Campsie. Council also submitted a report to Standing Committee on the parish of Bankstown.

8. Council also worked on the Clemton Park Sale Ordinance Review Panel Report and made recommendations regarding proceeds from the sale and a transfer of ministry residence to a neighboring parish.

9. Plans were developed to encourage Area Deaneries to take up opportunities for lay training and the matter of recruiting potential staff for regional parishes was discussed.

10. A detailed report on the impact of Roman Catholic World Youth Day was made available to parishes and Council is examining how Synod's Climate change resolution can be implemented regionally.

11. Council distributed 25 grants to 17 parishes and reported on the Clemton Park Land Sale and Variation of Trusts Ordinance. It made a loan available to the parish of Fairfield with Bossley Park for the demolition of the existing Bossley Park rectory and the construction of a replacement.

12. Regional Council continued to employ an Arabic Minister, an ESL Coordinator (part-time), a Refugee Support Network Coordinator (with support funding from the Archbishop's Community Care and

Development Program) and a Children's & Youth Task Force Coordinator (part-time).

13. Regional Council has continued its practice of meeting in various parishes across the region and in 2007 visited St George North, Lakemba, Mortdale, Chester Hill, Liverpool and Hurstville. This increased Council's knowledge of parish ministry across the region and provided parish with greater awareness of their regional council.
