Introduction

1. The Council met on five occasions during 2007, at St Andrew's Cathedral School in the city, preceded by a meal.

Ministry Report

3. Council has continued to work hard at the implications of the Diocesan Mission for churches and ministries in the South Sydney region. We are encouraged by the fact that each year at Synod another few of our parishes return to full parish status, a sign of the new life God is bringing to churches in the region. Council sees this as a satisfying result, in part, of its seed funding policy for parishes and ministries. We have moved much more to a pattern of funding which offers pre-defined amounts reducing over three years for new initiatives. This has meant the commencement of many new ministry positions as detailed below.

4. However, along with this has been the stalling of our two most recent church plants, at Green Square and Pyrmont. Council had driven these forward, but after giving them as much support as we could for as long as we could we are sad to report that neither has grown. In fact, the decision was made to close Pyrmont at the end of 2007, at least for the time being. We are grateful to God for that work, and the work at Green Square, which continues as part of South Sydney parish and express our thanks to the clergy and lay "pillars" who committed themselves so energetically to these two experiments. We are still assessing the effectiveness of Council's contribution and what we ought to learn.

5. In the course of the year discussions were held to bring about the amalgamation of the parishes of Ashfield and Five Dock/Haberfield. Council agreed to this in August and it became a reality on January 1 2008.

6. One of the ministries to commence in our region in 2007 is Maroubra Surfers' Church under the leadership of Rev Steve Bligh. This is primarily overseen by the Church Army, with support from several individual churches and the Regional Council. It has close links with St John's Maroubra. We are glad to support Steve in this ministry and look forward to what God will do through it.

7. On Saturday May 27 2007 Council held an extra meeting in the form of a Planning day , the results of which have been the subject of major items on the agenda since.

8. Council launched a Property Guidelines Manual for parishes undertaking property work. This folder of information has been given to all our parishes and is made available to others outside the region as well.

10. Consideration of ministry partnerships for 2008 was completed at the August 2007 meeting and successful applicants were notified.

Other Matters

11. The Council's Ordinance Review Panel met throughout the year, again under the skilled leadership of Mr Allan Pidgeon dealing with ordinances for the parishes of York Street, East Sydney, Annandale and Paddington.

12. Council recommended the raising of the parishes of Coogee and Newtown to full parish status, and this was agreed to by the Synod.

13. Council has been kept informed of the progress of plans for the eplacement of St Barnabas Church Broadway with a brand new and exciting building following the fire on May 10 2006.
