

St Saviour's South Sydney Ordinance 1978 Further Amendment Ordinance 1995

No 9, 1995

Long Title

An Ordinance to further amend the St Saviour's South Sydney Ordinance 1978 to provide further for the application of the income arising from certain property.

Preamble

Whereas

- A. By the St Saviour's South Sydney Ordinance 1978 (the "Principal Ordinance") provision was made for the application of income arising from the leasing of certain property.
- B. The authority to apply the income expired on 31 December 1994 and it is inexpedient to carry out and observe the trusts in the Principal Ordinance and it is expedient to make further provision for the application of the income.

Now the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the Synod Ordains, Directs, Declares and Rules as follows -

Citation

1. This ordinance may be cited as the "St Saviour's South Sydney Ordinance 1978 Further Amendment Ordinance 1995".

Declaration

2. By reason of circumstances which have arisen after the creation of the trusts declared in the Principal Ordinance it is inexpedient to carry out and observe those trusts and it is expedient that the trusts be varied as provided in this ordinance.

Amendment of Principal Ordinance

- 3. The Principal Ordinance is amended as follows -
- (a) at the end of clause 2 a further proviso is inserted as follows -

"Provided further that -

- (1) The annual net income derived on and from 1 January 1995 shall be applied as follows -
- (a) 70% to the Parochial Fund;
- (b) 10% to the Inner City Committee;
- (c) 10% to the Anglican Home Mission Society for aboriginal ministry in the Diocese of Sydney; and

- (d) 10% to be retained by the Property Trust to be applied on the request of the Churchwardens in writing, for the maintenance and development of church trust property in the Parish of St Saviour, South Sydney.
- (2) The annual net income derived after 31 December 1997 shall be applied in accordance with the provisions of an Ordinance presented pursuant to clause 3."; and
- (b) in clause 3 after the matter "1994" the following matter is inserted -

"and on or before 31 December 1997".

4. Clause 5 of the Principal Ordinance is repealed but without prejudice to any payment made under that clause prior to the date of assent to this Ordinance. Such payments shall be deemed to have been made under paragraph (1)(a) of the further proviso referred to in clause 3(a) of this Ordinance.
