St Thomas' Rozelle Ordinance 1987

(Reprinted under the Interpretation Ordinance 1985.)

The St Thomas' Rozelle Ordinance 1987 as amended by the St Thomas' Rozelle Ordinance 1987 Amendment Ordinance 1993, the Miscellaneous Amendments Ordinance 1996, the St Thomasff Rozelle Ordinance 1987 Amendment Ordinance 1996 and the St Thomasff Rozelle Ordinance 1987 Amendment Ordinance 1997.

Long Title

An Ordinance to vary the trusts on which certain money is held.

Preamble

Whereas

- A. On 26 March 1987 pursuant to the St Thomas' Rozelle Ordinance 1986 (the ô1986 Ordinanceö) the sale of certain land at Rozelle was completed.
- B. The net proceeds of the sale are held upon the trusts set out in clause 4 of the 1986 Ordinance.
- C. Clause 6 of the 1986 Ordinance requires an ordinance to be presented within 6 months after the date of completion of the sale to make further provision for the distribution of the money held under the 1986 Ordinance (ôthe moneyo).
- D. By reason of circumstances which have arisen subsequent to the creation of the trusts upon which the money it is held $\,$
 - (a) it is inexpedient to carry out and observe the same and it is expedient that the money be held or applied in accordance with the trusts declared in this Ordinance; and
 - (b) it is inexpedient to deal with or apply the money for the sole use and benefit of the Provisional Parish of Rozelle or for the same or like purposes.

Now the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod Hereby Ordains Declares Directs and Rules as follows.

Declaration of Inexpediency

- 1. By reason of circumstances which have arisen after the creation of the trusts upon which the land is held $\,$
 - (a) it is inexpedient to carry out and observe the same and it is expedient that the money be held or applied in accordance with the trusts declared in this Ordinance; and
 - (b) it is inexpedient to deal with or apply the money for the sole use and benefit of the Provisional Parish of Rozelle or for the same or like purposes.

Application of Proceeds

- 2. The money shall be applied as follows -
 - (a) \$30,000 shall be paid to the Archbishop of Sydney's Vision for Growth Appeal Fund;
 - (b) \$40,000 shall be paid to the Churchwardens for the time being of St Thomas' Church, Rozelle (the ôChurchwardensö), to be applied by them in the repair and restoration of -
 - (i) the properties of the Provisional Parish of Rozelle; and
 - (ii) the organ in St Thomas' Church, Rozelle; and
 - (c) the balance shall be invested in units of the Sydney Anglican Property Fund and the income from the investment shall be applied as follows -
 - (i) 12.5 per cent per annum shall be paid to the South Sydney Regional Council constituted under the Regions Ordinance 1995 to be applied by that Council for its purposes;
 - (ii); and
 - (ii) 87.5 per cent per annum shall be paid to the Churchwardens to be applied by them for purposes within the Provisional Parish of Rozelle∕Lilyfield.
- 3. The Churchwardens shall, on or before 31 December 2002, present an ordinance to the Synod of the Diocese of Sydney or the Standing Committee for the purpose of providing for the distribution of the money invested under this Ordinance or the income arising from the investment, or both, having regard to the needs and commitments of the Provisional Parish of Rozelle/Lilyfield and organisation within the Diocese of Sydney.

Citation

4. This Ordinance may be cited as the ôSt Thomas' Rozelle Ordinance 1987o.
