Death of Sir Harold Knight KBE DSC

Sir Harold served as a Lieutenant in the Australian Imperial Forces and Royal Australian Navy (1940-1945), where he was awarded the Distinguished Service Cross. Following the war, he worked for the International Monetary Fund (1955-59), before starting at the Reserve Bank of Australia in 1960, ultimately becoming its third Governor in 1975, holding that position until 1982. He was made a Knight of the British Empire in 1980 for his services to the banking industry. After retirement, he served on the boards of several major public companies and organisations, including as President of Scripture Union NSW (1983-2002).
