Commonwealth review of Religious Educational Institutions and Anti-Discrimination Laws

Response to the ALRC Consultation Paper

Standing Committee -

- (a) noted that on 27 January 2023, the Australian Law Reform Commission (ALRC) released its Consultation Paper on removing religious exemptions from the Sex Discrimination Act 1984 (Cth),
- (b) noted that the ALRC proposals will have a significant impact on Anglican Schools in the Diocese, because they will severely restrict the ability of a religious school to preference staff who share the faith of that school,
- (c) noted that responses to the ALRC Consultation Paper are due by 24 February 2023, and that the Religious Freedom Reference Group (RFRG) will submit a response on behalf of the Diocese,
- (d) noted that a briefing session for Heads and Chairs of Anglican Schools in the Diocese was held on Wednesday 8 February 2023, and
- (e) received an oral report from the Chair of the RFRG, Bishop Michael Stead.

The Archbishop thanked Bishop Stead on behalf of the Standing Committee, which was received with acclamation.

Correspondence with the Attorney-General

34/22 Religious Freedom

Standing Committee noted that Synod passed resolution 34/22 in the following terms -

'Synod –

- expresses its disappointment that there is still no NSW or Commonwealth legislation prohibiting religious discrimination, and therefore that it continues to be lawful to discriminate against people on the basis of their religious belief or religious activity in New South Wales,
- (b) calls on the NSW Government and the Commonwealth Government to reaffirm their commitment to religious freedom as set out in international law including Article 18 of the Universal Declaration of Human Rights and Article 18 of the International Covenant on Civil and Political Rights, and to take all practical steps necessary to ensure that the following six freedoms are protected in Australia within the constraints of the civil and criminal law generally applicable and consistent with Australia's obligations under international law
 - (i) freedom to manifest a religion through religious observance and practice,
 - (ii) freedom to preference the employment of persons of faith to organisations run by faith communities.
 - (iii) freedom to teach and uphold moral standards within faith communities and organisations run by faith communities,
 - (iv) freedom of conscience to differentiate between right and wrong,
 - (v) freedom to teach and propagate religion, and
 - (vi) freedom of a person to change their religion,
- (c) notes that Australia's obligations under Article 18 of the International Covenant on Civil and Political Rights to uphold freedom of religion is, in part, acquitted by means of legislative exemption clauses for religious bodies, and that that these exemption clauses only apply where "an act or practice conforms to the doctrines[, tenets, beliefs or teachings] of that religion" or words to that effect,
- (d) notes the 2020 Majority Opinion of the Appellate Tribunal in both the Wangaratta and Newcastle references sought to distinguish between "doctrine" in the technical sense in which that word is used in the Constitution of the Anglican Church of Australia (limited to those matters that which are required of necessity to be believed for salvation) and "doctrine" in the broader sense generally used in the Church,
- (e) recognises that, for the avoidance of doubt, it is expedient to affirm that past statements of this Synod about our Church's "doctrine" of marriage use the word in the generally accepted broader sense, and therefore that these statements continue to describe the "doctrines" of our Church,
- (f) in particular, this Synod continues to affirm that our doctrine of marriage is determined by the teaching of Christ that, "from the beginning the Creator made them male and female", and in marriage, "a man will leave his father and mother and be united to his wife, and the two will become one flesh" (Matt 19:4-5), and that it would not conform to the doctrine, tenets, beliefs or teachings of our Church for clergy to solemnise or bless a marriage between two people of the same sex.
- (g) affirms that when a Sydney Anglican Diocesan School seeks to teach and uphold the doctrine of Christ on marriage and human sexuality it does not thereby discriminate against students, parents and others in the school community who do not hold to these teachings; further, Synod laments the harm caused both among our school communities and the wider community by the propagation of suggestions to the contrary and supports the ongoing commitment of Anglican Schools to the inclusion, pastoral care and support of all members of their school communities,

and therefore calls upon both the NSW Government and the Commonwealth Government to give priority to the passage of legislation that respects the six freedoms listed above, and to do this in such a way that does not further polarise the community on these issues; and requests the

Diocesan Secretary to communicate this resolution to NSW and Federal Attorneys-General and shadow Attorneys-General.'

Broader charitable purposes of the diocese

- (d) further encourages all diocesan organisations to include in their annual reports to Synod a summary of the steps they have taken in pursuit of the broader charitable purposes of the Diocese."

- (b) expectations regarding how any money "earned" for provision of such services should be paid (e.g. to the worker's parish rather than to the worker themselves).

She was active in ministry within the Sydney Diocese before she was admitted as a deaconess in 1985 upon her appointment as Principal of Mary Andrews College (formerly Deaconess House). She was ordained Deacon in 1989, among the first cohort of female deacons. As Principal of Mary Andrews College, Narelle had a significant role in training and development of the female students at Moore Theological College, as well as serving as a lecturer in Church History and Pastoral Care and training lay women across the Diocese. In 2002, she was appointed Archdeacon for Women's Ministry, while continuing as Principal of Mary Andrews College.

In 2008 she became Archdeacon full time and held this position until her retirement in 2012. Narelle also served on various boards such as the Council of Ministry Training & Development, the Mission Task Force, the Standing Committee and Synod of the Sydney Diocese as well as General Synod. She was active in the governance of the Archbishop's Overseas Mission Fund and Anglican Deaconess Ministries. She also served as an Honorary Minister at South Coogee. Synod gives thanks to God for Narelle's valuable contribution to the life of our Diocese, her passion for advancing the ministries of women and her commitment to biblical truth and making Christ known.'

He also has been a member of the Moore Theological College Council and the Diocesan Tribunal since 1981, the Nomination Board (formerly Presentation Board) since 1993, and was a trustee of the Anglican Church Property Trust for over 42 years, including fifteen as Chairman of the Board. He was appointed as Deputy Chancellor in 2009 and has been on countless Synod and Standing Committee committees over the years, including over twenty years as an Ordinance Reviewer.

Over and above all of this, Robert has also been highly engaged with national church matters for over 40 years. He was elected as a Diocesan representative on General Synod, and Diocesan representative on Provincial Synod, both in 1979. At a national level, he has served on the Standing Committee, Church Law Committee and Audit Committee, and as the Chancellor to the Diocese of The Murray. He was appointed as a member of the Order of Australia in 2010, for service to the Anglican Church of Australia through a range of diocesan and national executive and administrative roles, and to the law as a practitioner and as an academic.

At the Anglican Communion level, Robert was the lay representative of the Anglican Church of Australia at the Anglican Consultative Council meeting in Panama, Lambeth Conference (1998) and Dundee, and a member of the Archbishop of Canterbury's Panel of Reference arising from the Windsor Report. He is presently the Leader of the Gafcon Lawyers Task Force."

We encourage all church members to prayerfully seek God's voice as they search his wisdom in considering a 'yes' vote for the approaching referendum."

- (c) commends the decision by Anglicare Sydney to continue providing aged care services whilst adopting an approach that refuses to actively support euthanasia but complies with the Act, regulations and guidelines,
- (d) prays for the care and protection of all residents, their families and friends, and the staff, executives, and Board of Anglicare Sydney, as access to voluntary assisted dying becomes available on 28 November 2023 and beyond, and
- (e) reaffirms its opposition to voluntary assisted dying and calls on the NSW Parliament to repeal the Act, and failing that to administer the Act in such a manner as to permit faithbased organisations, including residential aged care providers, who oppose euthanasia on the grounds of institutional conscientious objection, not to participate in, facilitate or permit voluntary assisted dying in or at their premises, facilities or services in any way.'

- (a) noted the report "You win some, you lose more: Online gambling and its impacts on those experiencing gambling harm" issued unanimously by the members of the federal House of Representatives' Standing Committee on Social Policy and Legal Affairs,
- (b) commend the committee members for their incisive and cooperative work on research-informed reform for the prevention online gambling harm, and
- (c) respectfully request the Archbishop to write to the Prime Minister and Leader of the Opposition, commending the unanimous report, and urging them to act promptly, and in a bipartisan way, to legislate for the reforms recommended by the report, as a matter of urgency in a public health context, especially the recommendations
 - (i) that the Australian Government prohibit all online gambling inducements and inducement advertising, and that it do so without delay (Recommendation 16), and
 - (ii) that the Australian Government, with the cooperation of the states and territories, implement a comprehensive ban on all forms of advertising for online gambling, to be introduced in four phases, over three years, commencing immediately (Recommendation 26).

- (b) requested the Affiliated Churches Committee to promote suitable legislation to wind down the Affiliated Churches Program.

9/23 Ministry Standards Ordinance 2017

Standing Committee noted that Synod passed resolution 9/23 in the following terms -

'Synod, noting that the *Ministry Standards Ordinance 2017* (MSO) has been in operation for five years, asks Standing Committee to investigate –

- (a) the impact of the complaints processes of the Office of the Director of Safe Ministry (ODSM) under the MSO on church workers, their families, and their parish ministry, including duration of complaints handling, impact of confidentiality requirements, perceptions of the investigation process, and general confidence in the process,
- (b) the adequacy of support arrangements for complainants and respondents involved in ODSM processes,
- (c) the cost of processing complaints that ultimately do not proceed, or return no finding of unfitness, and how those costs can be minimised,
- (d) what steps can be taken to minimise negative impacts on church workers and their families that result from false, trivial or vexatious complaints,
- (e) whether the shift to a fitness for office test has achieved the intended objectives, what costs it has involved, and whether it should be maintained,
- (f) whether complaints of child sexual abuse and bullying are best governed by a common process and/or ordinance, or whether these complaints require different approaches, processes and/or ordinances,
- (g) the extent to which the biblical necessity for church discipline and the practical requirements of such church discipline are properly considered in our approach to, and definitions of, bullying and harassment, and
- (h) how we can make better use of the Diocesan policy for dealing with allegations of unacceptable behaviour and other processes in resolving conflict apart from the MSO,

and report its findings and recommendations to the 2024 session of Synod.'

and agreed to consider appointing a committee to address the request of resolution 9/23 at its meeting on 20 November 2023.

10/23 Leadership of Indigenous Ministry in the Diocese

Noting of Synod resolution

Standing Committee noted that Synod passed resolution 10/23 in the following terms -

'Synod, noting the report "Leadership of Indigenous Ministry in the Diocese" -

- (a) expresses its gratitude for the work of the volunteers who serve on the Sydney Anglican Indigenous Peoples' Ministry Committee (SAIPMC),
- (b) notes the report from the SAIPMC that Indigenous ministry in the Diocese is hampered because a committee of volunteers is not able to lead and drive the vision for Indigenous ministry (and true gospel reconciliation) across our Diocese and beyond,
- (c) expresses in-principle support for the recommendation of SAIPMC for the recognition and appointment of an Indigenous person (or persons) to lead and represent Indigenous ministry in our Diocese.
- (d) requests the Standing Committee to appoint a committee to explore how best to implement the recommendation of SAIPMC. The committee should consider
 - (i) the scope of the role,

- (ii) whether this role should be full time or part time, and/or a possible staged implementation,
- (iii) whether there should be Indigenous representation on the Standing Committee,
- (iv) the appropriate form of appointment (e.g., Canon, Archdeacon or Bishop), and
- (v) the funding of this role, and
- (e) requests, to the extent that the recommendations of the committee require ordinance changes, that such changes be brought to the next session of the Synod for consideration.'

and agreed to consider appointing a committee to address the request of resolution 10/23 at its meeting on 20 November 2023.

Noting of SAIPMC request

Standing Committee noted the following motion passed by the Sydney Anglican Indigenous Peoples' Ministry Committee on 23 September 2023 –

'The SAIPMC, noting the passing by the Synod of Motion 10/23 <u>Leadership of Indigenous Ministry in the Diocese</u>; requests the Standing Committee appoint to the proposed Committee a minimum of two Indigenous persons and requests these positions be filled by the two current Indigenous members of the Synod: Ms Larissa Minniecon and Rev Michael Paduch-Duckett.'

12/23 Implementation of recommendations of the Royal Commission into Institutional Responses to Child Sexual Abuse

Standing Committee noted that Synod passed resolution 12/23 in the following terms -

'Synod, noting the report "7/22 Implementation of the Recommendations of the Royal Commission into Institutional Child Sexual Abuse", requests the Standing Committee to provide a further update to the next session of the Synod in relation to implementation of the actions set out in the table to the report.'

and -

- (a) referred the request of the resolution to the Safe Ministry Board,
- (b) noted that the Exposure Draft of the revised Governance Policy for Diocesan Organisations includes at paragraph H.(g)(i) that members of Tier 1, 3 and 4 organisations must undertake safe ministry training, which, if implemented, will address recommendation 16.50, and
- (c) request the Board to provide a suitable report by the July 2024 meeting of the Standing Committee for promotion to the next ordinary session of the Synod.

15/23 Funding for Work Outside the Diocese

Standing Committee noted that Synod passed resolution 15/23 in the following terms -

'Synod notes that -

- (a) the Work Outside the Diocese allocation for 2024 in the *Synod Appropriation and Allocations Ordinance* 2023 is based on 4.5% of the total income available to Synod,
- (b) this is despite a 22% increase in available income compared to 2023,
- (c) past Synods have requested 5% of the available income to be applied for this purpose, and
- (d) the relevant report states that the percentage reduction is temporary,

and therefore requests Standing Committee to work towards appropriation bills that return to the policy of applying 5% of available income for Work Outside the Diocese in future years.'

and referred the request of the resolution to the Diocesan Resources Committee.

21/23 Diocesan Organisations pursuing the broader charitable purposes of the Diocese

Standing Committee noted that Synod passed resolution 21/23 in the following terms -

'Synod, recognising the increasing need for, and benefits of, diocesan organisations working together as part of the broader diocesan network –

- (a) recognises the document Purpose and Priorities for our Diocesan Fellowship as an expression of the 'broader charitable purposes of the Diocese' for the purposes of the Synod's Governance Policy for Diocesan Organisations,
- (b) notes that, in conformity with the Synod's Governance Policy, a number of diocesan organisations have sought and obtained amendments to their constituting ordinances which expressly permit them to pursue their specifically mandated purpose in a manner which also advances the broader charitable purposes of the Diocese,
- (c) regards such amendments as a tangible expression of commitment to working together as part of the broader diocesan network and encourages all diocesan organisations, to the extent they are legally able to do so, to consider seeking such amendments,
- (d) requires all Category Two and Category Three diocesan organisations (under the Accounts, Audits and Annual Reports Ordinance 1995), except for schools, to annually report to Synod a summary of the steps they have taken in pursuit of the broader charitable purposes of the Diocese, and
- (e) encourages all Diocesan schools (mentioned in Category Three of the Accounts, Audits and Annual Reports Ordinance 1995) to annually report to Synod a summary of the steps they have taken in pursuit of the broader charitable purposes of the Diocese.'

and -

- (a) noted that the Diocesan Secretary has conveyed the terms of the resolution to all diocesan organisations and schools, drawing particular attention to paragraphs (c), (d), and (e) as appropriate,
- (b) requested the Diocesan Secretary to arrange for an ordinance to amend the *Accounts, Audits and Annual Reports Ordinance 1995* to enact the requirement of the Synod in paragraph (d), to be brought to a future meeting.

24/23 South Western Region buildings and property strategy

Standing Committee noted that Synod passed resolution 24/23 in the following terms -

'Synod, noting the report "South Western Region buildings and property strategy" -

- (a) notes that the members of Synod have been invited to provide feedback on the draft South Western Region Buildings and Property Strategy, and that they can send their feedback on the Strategy to the Diocesan Secretary (<u>DiocesanSecretary@sydney.anglican.asn.au</u>) by 30 November 2023,
- (b) requests the Standing Committee to consider approving the South Western Region Buildings and Property Strategy, having taken into account the feedback from Synod members, and
- (c) requests the Standing Committee to prepare the remaining four Regional strategies and an over-arching Diocesan-wide property strategy in support of ministry and report back to the next session of the Synod.'

and requested the Anglican Church Growth Corporation to -

- (a) assess the feedback received once the submission period has closed,
- (b) provide a final form of the South Western Region Buildings and Property Strategy, having taken into account the feedback from Synod members, to the Standing Committee for approval by February 2024, and
- (c) report to the March 2024 meeting of the Standing Committee with a recommended way forward regarding the remaining four Regional strategies and an over-arching Diocesan-wide strategy.

28/23 Questions during debates on motions

- (a) invites members of the Synod to provide feedback to the Diocesan Secretary by 31 December 2023 on the proposed arrangements for all ministry workers in the Diocese to undergo regular performance appraisals as contemplated in the report, and
- (b) requests the Standing Committee to implement arrangements for regular performance appraisals for all ministry workers in light of feedback received.'

and agreed to consider appointing a Committee to address the request of resolution 32/23 at its meeting on 20 November 2023.

48/23 Non-Disclosure Agreements

Standing Committee noted that Synod passed resolution 48/23 in the following terms -

'Synod -

- (a) gives thanks for the important work of the committee established by the Standing Committee to review the use of Non-Disclosure Agreements and Non-Disparagement Clauses in the Diocese.
- (b) grieves that such agreements could be used to silence victims and cover up sin,
- (c) requests that the committee's report be presented at the next session of Synod with a recommendation concerning the use of such agreements in our Diocese, and
- (d) prays for those impacted negatively by these agreements.'

and noted that the Diocesan Secretary has referred the request of the resolution to the Non-Disclosure Agreement Committee and requested a report be provided by July 2024 for promotion to the Synod.

52/23 Pastoral Supervision in the Diocese of Sydney

Noting of Synod resolution

Standing Committee noted that Synod passed resolution 52/23 in the following terms -

'Synod, noting the report "Pastoral Supervision in the Diocese of Sydney" –

- (a) affirms the importance of Pastoral Supervision, both as a measure to enhance the ministry wellbeing and development of church workers in the Diocese, and to implement a recommendation of the Royal Commission into Institutional Responses to Child Sexual Abuse,
- (b) requests the Archbishop-in-Council to approve a Pastoral Supervision Policy as provided for by the Pastoral Supervision Ordinance 2023,
- (c) requests that the Pastoral Supervision Policy include a review date five years in the future, and
- (d) requests Standing Committee give consideration to facilitating professional research to evaluate the effect of the policy during the review period.

Synod also requests that -

- consideration be given to exempting from the requirement for pastoral supervision new assistant ministers and other church workers undertaking the 3-year postcollege Ministry Development program, given their program already involves guided reflection, mentoring, participation in 360-degree feedback and use of other psychometric tools,
- (ii) in the production of the Pastoral Supervision policy, consideration be given to including options for costless or low-cost forms of pastoral supervision, including but not limited to group pastoral supervision,
- (iii) alongside and in conjunction with the production of the Pastoral Supervision Policy, a holistic consideration of the whole suite of expectations on ministry workers' time (with regard to training, support and development) be conducted in order to determine if there are redundancies that can be eliminated to make up for the added time and potential cost of pastoral supervision, and
- (iv) the Pastoral Supervision Policy provide for the confidentiality of discussions between church workers and Pastoral Supervisors.'

and noted that the Diocesan Secretary has referred the request of the resolution to the Pastoral Supervision Committee and requested a revised Pastoral Supervision Policy be promoted to the Standing Committee for approval, incorporating the matters in paragraph (c) and subparagraphs (i) to (iv).

Receipt of correspondence

Standing Committee received a letter from the Rev Gavin Poole regarding Resolution 52/23, and referred it to the Pastoral Supervision Committee for consideration.

53/23 General Synod Long Service Leave Fund

Standing Committee noted that Synod passed resolution 53/23 in the following terms -

'Synod -

- (a) notes the General Synod Long Service Leave Fund was established by a General Synod canon more than 60 years ago when the forms of paid ministry were very different to the various ministries which exist now, and
- (b) asks the Standing Committee
 - to consider whether the circumstances have changed so much over the last 60 years that it may be wise to establish a Sydney Long Service Leave Fund which could have the flexibility to reflect modern ministry arrangements,
 - (ii) to consult with the Board of the General Synod Long Service Leave Fund, former members of the Board and others as appropriate, and take whatever action it considers to be in the best interests of the ongoing ministry both in the Diocese of Sydney and the wider Australian church.'

and -

- (a) referred the request of the resolution to the General Synod Relations Committee, and
- (b) requested the Committee to bring a report with recommendations to a future meeting of the Standing Committee for promotion to the next ordinary session of the Synod.

54/23 Temporary arrangements for diocesan schools

Noting of Synod resolution

Standing Committee noted that Synod passed resolution 54/23 in the following terms -

"Synod, noting -

- (i) that it has endorsed the approach of requiring governors and leaders to be of Christian faith and character, as outlined in the Exposure Draft of the revised Diocesan Governance Policy, to be further considered at the Synod next year, and
- (ii) that the Synod has not yet made a decision whether the new Diocesan Governance Policy will require a signed Statement of Personal Faith,

encourages the Standing Committee to -

- (a) consider approving appropriate temporary arrangements for Diocesan schools based on the proposed 'Christian faith and character' model, provided that the temporary arrangements also require a signed Statement of Personal Faith in the form currently required by ordinance from the majority of Diocesan schools, and
- (b) report progress to each future session of Synod until these arrangements are no longer required.'

and noted that schools that wish to pursue 'appropriate temporary arrangements' should contact SDS Legal to request an ordinance.

56/23 Partnership with Anglican Schools

Standing Committee noted that Synod passed resolution 56/23 in the following terms -

'Synod, noting the report "Recommendations from the Education Committee" -

- (a) acknowledges and thanks Anglican Schools for their work as partners in the mission and ministry of the Diocese,
- (b) requests the draft statement on Reformed Anglican Education be presented to School Principals and ordained chaplains for their consideration and comment, particularly with reference to the nature and purposes of Anglican Schools within the larger context of Reformed Anglican Education,
- (c) requests the Standing Committee to form a suitably qualified committee, including current Anglican School principals and ordained chaplain(s), to prepare a draft statement for adoption by the Synod in due course, and
- (d) encourages participation by Anglican School staff in mentoring, professional development and networking through diocesan associations and professional bodies.'

and agreed to consider appointing a committee to address the request of resolution 56/23 at its meeting on 20 November 2023.

57/23 Training opportunities for Anglican educators

Standing Committee noted that Synod passed resolution 57/23 in the following terms -

'Synod recommends that the Standing Committee -

- (a) request SDS to include instructional training that provides contextual information about the Diocese and its structures in conjunction with SDS supported AICD governance courses, and to offer this training or an alternate version to diocesan school staff (possibly using a similar online platform as is currently operating for safe ministry training),
- (b) request the education advisor (or, in the absence of an education advisor, the Archbishop's delegate) to consult and work collaboratively with suitably qualified chaplains and heads of Christian Studies to determine time- and cost-effective models and pathways for interschool Christian Professional Development for Christian teachers, including proposals for suitable tertiary institutional engagement (if any),
- (c) request the education advisor (or, in the absence of an education advisor, the Archbishop's delegate) to develop partnerships with university Christian fellowships in order to promote training opportunities and access to tertiary courses with cross-institutional credit which train teacher education students in distinctively Christian teaching,
- (d) request the education advisor (or, in the absence of an education advisor, the Archbishop's delegate) to report to the Standing Committee the findings at (b) for review and presentation to Synod, and
- (e) consider ways to fund such requests.'

and -

- (a) referred the request of paragraph (a) to SDS.
- (b) noted that the proposal regarding an education advisor was not voted on by the Synod,
- (c) referred the requests of paragraph (b) to (d) to the Archbishop's delegate, and
- (d) requested the Archbishop's delegate to bring recommendations to the Standing Committee about what funding may be required to enact these recommendations.

64/23 Attendance Patterns and Mission in the Diocese

Standing Committee noted that Synod passed resolution 64/23 in the following terms -

"Synod -

- (a) gives thanks to the Lord for -
 - (i) the faithful Anglican ministry efforts of both laity and clergy since 1788,
 - (ii) the crucial work of Moore Theological College, Anglicare, Youthworks, diocesan schools and other ministry organisations, in supporting the ministry of the Diocese's churches,
 - (iii) the visionary and theological leadership of archbishops, past and present, and
 - (iv) the property and financial resources which facilitate the ministry of the Word,

which have all contributed to almost 40% of the national Anglican Church's weekly attendance being within the geographical boundaries of the Diocese of Sydney,

- (b) therefore encourages all Sydney Anglicans to pray for the lost, so that the Lord would open their eyes and turn them from darkness to light, and from the power of Satan to God, so that they may receive forgiveness of sins and a place among those who are sanctified by faith in Christ (Acts 26:18).
- (c) notes -
 - (i) the baby boomer generation, which constitutes a large percentage of the average attendance per week, has begun its progression to glory,
 - (ii) the population within the boundaries of the Diocese is booming and is projected to include an additional one million people by 2041,
 - (iii) the majority of that net population growth is expected to reside within the brownfield areas of Sydney, and
 - (iv) the challenges of ministering with ageing and often inadequate infrastructure within those brownfield areas.
- (d) further notes the external, forthcoming government-imposed challenges to overcome, that may adversely affect the impact of our ministries, and
- (e) requests the Standing Committee to initiate an analysis of average attendance trends, and an assessment of the likely impact of social changes upon average attendance, and report back to Synod in 2024."

and agreed to consider appointing a committee to address the request of resolution 64/23 at its meeting on 20 November 2023.

Second session of the 53rd Synod

Standing Committee noted the dates for the second session of the 53rd Session of the Synod are Saturday 14 (Synod in the Northwest Greenfields event), Monday 16, Tuesday 17, Wednesday 18, Monday 23 and Tuesday 24 September 2024.

13/23 New Diocesan Bishops

Standing Committee noted that Synod passed resolution 13/23 in the following terms -

'Synod -

- (a) notes that, since it last met -
 - (i) the Ven Darrell Parker was consecrated at St Andrew's Cathedral on 3 February 2023 and installed as the eighth Bishop of North West Australia at Holy Cross Cathedral in Geraldton on Wednesday 15 February 2023,
 - (ii) the Right Rev Jeremy James was installed in the Cathedral of St Peter and St Paul, Port Pirie as the eighth Bishop of Willochra on 25 February 2023, and
 - (iii) the Right Rev Jeremy Greaves was elected on 26 August 2023 as the tenth Archbishop of Brisbane and Metropolitan of the Province of Queensland, and will be installed on 16 December 2023 at St John's Cathedral, and
- (b) assures these bishops of our prayers and good wishes in their episcopal roles, praying -

Lord, bless your servants Darrell, Jeremy and Jeremy called to the work and ministry of a bishop. So fill them with the truth of your doctrine and clothe them with holiness of life, that they may faithfully minister in this office to the glory of your name and the benefit of your Church. We ask this through our Lord Jesus Christ, who lives and reigns with you and the Holy Spirit, one God, now and for ever. Amen.

Church of England General Synod

Standing Committee -

- (a) grieved the decision of the Church of England General Synod to encourage the House of Bishops to continue their work of implementation of the Prayers of Love and Faith, including the development of 'stand alone' services for the blessing of people in same-sex marriages, in a clear departure from the teaching of Scripture,
- (b) noted that the motion was passed by very narrow margins in the Houses of Clergy and Laity (100/93 and 104/100 respectively) but by a significant margin in the House of Bishops (23/10),
- (c) commended all those who upheld the teaching of Scripture, the doctrine of marriage as expressed in the Book of Common Prayer, and Lambeth Resolution I.10 by voting against the motion,
- (d) called on the General Synod to repent of this decision and joyfully affirm the authority and trustworthiness of the Holy Scriptures in matters of human sexuality and marriage, including for people who identify as gay and lesbian,
- (e) called on the House of Bishops to uphold their consecration vows to 'banish and drive away all erroneous and strange doctrine contrary to God's Word' by halting implementation of the Prayers of Love and Faith,
- (f) assured all members of the Church of England of our prayers in this time of deep distress and division, and our solidarity with those who seek to uphold the teaching of Scripture including those who experience attraction to people of the same sex and live faithful and chaste lives of fruitful and joyful service of the Lord in the fellowship of his people, and

(g) requested a copy of this resolution be sent to the Archbishop of Canterbury, and the Director of the Church of England Evangelical Council.

Bishop Malcolm Richards led the Standing Committee in prayer regarding this matter.

- (a) remuneration and expenses for Pastoral Supervisors engaged in stipendiary ministry, and
- (b) parish contributions for the cost of receiving Pastoral Supervision.

Response to correspondence

Standing Committee requested the Diocesan Secretary to respond to the Rev Gavin Poole's letter dated 20 October 2023 to advise him of the Archbishop-in-Council's decision on these matters.

Request for professional research

Sydney Anglican Property (Provisional Restructuring) Ordinance 2023

Purpose of ordinance

Declaration of vacancies and election of members

Standing Committee, under section 12 of the *Anglican Church of Australia Trust Property Act 1917* and with effect from 1 January 2024 –

- (a) declared vacancies in the office of all members of the Anglican Church Property Trust Diocese of Sydney (ACPT) (except the Archbishop of Sydney) by reason of the establishment of the Sydney Anglican Property board structure (as part of a broader restructure of the central affairs of the Diocese), and
- (a) elected, subject to their consent, the persons listed in subclause 9(1) of the Sydney Anglican Property (Provisional Restructuring) Ordinance 2023 as members of the ACPT.

Acknowledgment and thanks for retiring members

Standing Committee –

- (a) noted that, as a consequence of the elections of persons listed in the Sydney Anglican Property (Provisional Restructuring) Ordinance 2023, a total of 13 persons will not be continuing as members of their respective organisations,
- (b) acknowledged the collective 129 years of service to the Anglican Church Property Trust, St Andrew's House Corporation, and Anglican Church Growth Corporation represented by the 13 retiring members, and
- (c) thanked each of the retiring members for their contribution to the wise stewardship of these organisations over many years.

25/23 Online Sports Betting - Federal Harm Reduction

Standing Committee noted that Synod passed resolution 25/23 in the following terms -

'Synod, noting that the Bible says, "Whoever mocks the poor insults his Maker; he who is glad at calamity will not go unpunished." (Proverbs 17:5) –

- (a) thanks the Federal Government for the steps they have already taken to address the public health crisis that is caused by online sports betting; in particular that the Federal Government has
 - (i) introduced the "You win some, you lose more" campaign which mandated clearer warnings about the harms of online sports betting,
 - (ii) mandated that advertising for online sports betting include contact details of support services that can assist individuals experiencing gambling harm, and
 - (iii) held a wide ranging Parliamentary inquiry titled "You win some, you lose more: Inquiry into online gambling and its impacts on those experiencing gambling harm" producing unanimous bipartisan recommendations,
- (b) calls on the Federal Parliament, in light of this above inquiry and report, to implement the full 31 recommendations of the committee; in particular, that
 - (i) the responsibility for online gambling harm reduction be held by a single Australian Government Minister (Recommendation 1),
 - (ii) the Australian Government prohibit all online gambling inducements and inducement advertising, without delay (Recommendation 16), and
 - (iii) the Australian Government implement a comprehensive ban on all forms of advertising for online gambling, with the phased implementation commencing as soon as possible (Recommendation 26),

- (c) requested that the Diocesan Secretary communicate the contents of this resolution to the Prime Minister and the Leader of the Federal Opposition, along with the Minister for Communications, and the Minister for Social Services, and
- (d) encourages all members of Synod to write to their local Federal Members of Parliament urging them to support and implement all the recommendations of the 'You win some, you lose more: Inquiry into online gambling and its impacts on those experiencing gambling harm' report.'

and noted a response from Ms Anthea Fell, Assistant Secretary for the Department of the Prime Minister and Cabinet.

26/23 NSW Poker Machine Use - State Harm Reduction

Standing Committee noted that Synod passed resolution 26/23 in the following terms -

'Synod, noting that -

- (i) Almighty God calls on governing rulers to 'defend the weak and the fatherless; uphold the cause of the poor and the oppressed; (Psalm 82:3),
- (ii) \$8 billion is lost annually through poker machines in NSW (i.e., approximately \$23 million every day), disproportionately from lower socioeconomic areas of NSW, where poker machines are often most concentrated, and
- (iii) documents recently tabled in the NSW Parliament from a 2021 series of club inspections, as part of an Anti-Money Laundering Project run by NSW Liquor and Gaming and the NSW Crime Commission, revealed investigators suspected \$5.5 million was laundered through 178 venues, just in a seven week period, with ten venues accounting for more than 40% of that total, mainly located in south-west Sydney,
- (a) thanks the NSW State Government for the steps it has already taken to address the public health crisis that is caused by poker machine gambling in NSW; in particular that the NSW State Government has –
 - (i) shepherded legislation through the NSW Parliament to ban political donations from licensed clubs with poker machines,
 - (ii) instructed Liquor & Gaming NSW to enforce laws already in place to eliminate external gambling-related advertising, and
 - (iii) committed to a trial of a mandatory cashless gambling card system for poker machines in NSW, to be overseen by an independent advisory panel comprised of industry, harm minimisation, academic, cyber crime, police, and union representatives,
- (b) calls on the NSW Government to implement this trial as swiftly as possible, within a framework of pre-implementation testing for a mandatory cashless gaming card, which public health, law enforcement and welfare policy experts have already recommended as a most effective harm minimisation method, both for problems caused by gambling and by money-laundering,
- (c) supports urgent consideration by the NSW Government of the calls from NSW MPs
 - (i) requesting a Royal Commission into the conduct, integrity and influence of the gambling industry in NSW, and
 - transferring regulation and oversight of 'casino-like' clubs operating more than 250 gaming machines from the Independent Liquor and Gaming Authority to the NSW Independent Casino Commission,
- (d) requested that the Diocesan Secretary communicate the contents of this resolution to the Premier of NSW, the NSW Leader of the Opposition, and the Minister for Gaming and Racing, and
- (e) encourages all members of Synod to write to their local Members of the Parliament of NSW urging them to work diligently towards reducing the misery caused by poker machine gambling.'

and noted a response from the Hon David Harris MP, Minister for Gaming and Racing.
