Long Title

An Ordinance to constitute a council for the purpose of managing, governing and controlling preschool kindergarten and child-care centres conducted on church trust property in the Diocese of Sydney.

Preamble

Whereas it is desirable that provision be made for governing and controlling the management and uses of church trust property on which pre-school kindergartens and child-care centres are conducted Now the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod Hereby Ordains Declares Directs and Rules as follows –

Citation

1. This Ordinance may be cited as "Sydney Anglican Pre-School Council Ordinance 1975".

Interpretation

- 2. (1) In this Ordinance, unless inconsistent with the context or subject matter
 - (a) "Council" means the council hereby constituted.
 - (b) "Synod" means the Synod of the Diocese of Sydney.
 - (c) "Standing Committee" means the Standing Committee of Synod.
 - (d) "Archbishop" means the Archbishop of the Diocese of Sydney.
 - (e) "Property Trust" means Anglican Church Property Trust Diocese of Sydney.
- (2) Words importing the masculine gender include the feminine gender, words importing persons include corporations and words importing the singular number include the plural number and vice versa.
- (3) The headings contained in this Ordinance have been inserted as a matter of convenience only and shall not limit or restrict the provisions of this Ordinance in any way.

Council

- 3. (1) The members of the Council are any two members of the Property Trust nominated by the Property Trust by resolution from time to time.
- (2) No omission to elect any member or members nor any informality or defect in the method of such election nor any vacancy or vacancies in the office of member shall affect the authority or powers of the Council and, subject to the provisions as to a quorum, such authority and powers may be exercised by the members for the time being holding office.

Proceedings

- 4. The members of the Council shall meet at such times and in such places and conduct the business of the Council in such manner as the said members consider appropriate.

Report

6. (1) The Council shall furnish to the Synod or to the Standing Committee any information which it may be requested so to do in pursuance of a resolution of the Synod or of the Standing Committee and shall at least once in every year report its proceedings to the Synod.

Notes

Pursuant to the Anglican Church of Australia (Bodies Corporate) Act 1938, the Council was incorporated under the name "Sydney Anglican Pre-School Council" by Order published in the Government Gazette on 20 February 1976.
