# Sydney Anglican Schools Corporation Ordinance 1947 Amendment Ordinance 2008

No 8, 2008

## **Long Title**

An Ordinance to amend the Sydney Anglican Schools Corporation Ordinance 1947.

## **Preamble**

- A. Sydney Anglican Schools Corporation is constituted pursuant to Sydney Anglican Schools Corporation 1947 (the "Principal Ordinance").
- B. The Members of Sydney Anglican Schools Corporation have resolved to seek amendments to the size of its Membership, its Board of Directors and its School Councils for the purposes of better governance.

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows.

#### Name

This Ordinance is the Sydney Anglican Schools Corporation Ordinance 1947 Amendment Ordinance 2008.

## 2. Amendments

- (1) Clause 9 of the Principal Ordinance is amended in clause 9.1(c) by deleting the matter "twenty (20)" and inserting in its place the matter "twenty-four (24)".
- (2) Clause 14 of the Principal Ordinance is amended as follows
  - (a) in clause 14.2 delete the matter "nine" and insert in its place the matter "at least nine, and up to twelve,"
  - (b) in clause 14.6 delete the matter "4" and insert in its place the matter "one half (1/2) of the number of Directors, or if there is an odd number of Directors, then a majority of the number of Directors".
- (3) Clause 15 of the Principal Ordinance is amended as follows -
  - (a) in clause 15.3(c) delete the matter "Eight additional persons (or seven in the case of a preparatory school)" and insert in its place the matter "At least five, and up to nine, additional persons", and
  - (b) insert a new paragraph (e) as follows (with consequential relettering of the existing paragraph (e))
    - "(e) A quorum for a meeting of a School Council shall be one half (1/2) of the number of non-ex-officio School Council members, or if there is an odd number of non-ex-officio School Council members, then a majority of the number of non-ex-officio members of a School Council."

### 3. Transition

For the purposes of clause 2(1) of this Ordinance, the Standing Committee may elect the 4 additional persons as Members of the Corporation. Such persons are to be treated as if they had been elected by the Synod at the second ordinary session of the 47th Synod.
