## Sydney Church Ordinance 1912-1961 Amendment Ordinance 1966

## No. 34, 1966.

An Ordinance to amend the Sydney Church Ordinance 1912-1961.

Wheneas Ordinance No. 40, 1961, was passed by the Synod shortly after the passing of the Sydney Church Ordinance 1912 Amendment Ordinance 1961 and contains an error as a result of the order in which the said Ordinances were passed by the Synod at that time And Wheneas it is expedient to correct the said error and to make further amendments to the Sydney Church Ordinance 1912-196E.

NOW the Synod of the Diocese of Sydney in pursuance of the powers in that behalf conferred upon it by the Constitutions for the management and good government of the Church of England in Australia within the State of New South Wales ordains and rules as follows:-

- 1. This Ordinance may be cited as the "Sydney Church Ordinance 1912-1961 Amendment Ordinance 1966."
- 2. In this Ordinance "Principal Ordinance" means the Sydney Church Ordinance 1912-1981.
- 3. The Principal Ordinance as amended by this Ordinance may be cited as the "Sydney Church Ordinance 1912-1966."
- Section 1 of the Principal Ordinance is amended by inserting the figures "-1986" after the figures "1912."
- 5 Sub-clause (7) of Clause 20 of Ordinance No. 40, 1961, entituled "Sydney Diocesan Superannuation Fund Ordinance 1961" is amended by deleting the figure "(5) where occurring and inserting in its place the figure "(4)."

This amendment shall be deemed to have taken effect at and from the date upon which the said Ordinance took effect.

- 6. Section 51 of the Principal Ordinance is amended
  - (i) by inserting "as follows" after "shall be" and
  - (ii) by inserting the following new clause (5a) after clause 5:
    - (5a) To confer with the Minister in the initiation, conduct and development of Church work including such matters as are vital to the spiritual welfare of the Church within or outside the Parish.

- 7. Section 52 of the Principal Ordinance is amended
  - (i) by inserting "as follows" after "shall be" and
  - (ii) by inserting the following new clause (8a) after clause (8): (8a) To confer with the Minister in the initiation, conduct and development of Church work including such matters as are vital to the spiritual welfare of the

Church within or outside the Parish.
