SYDNEY DIOCESAN SICKNESS AND

ACCIDENT FUND ORDINANCE 1969-1981

AMENDING ORDINANCE 1982

NO. 6 1982

AN ORDINANCE to change the provisions regarding the government and control of the Sydney Diocesan Sickness and Accident Fund and for purposes incidental thereto.

WHEREAS it is expedient that Sydney Diocesan Secretariat manage the Sydney Diocesan Sickness and Accident Fund NOW the Standing Committee of the Synod of the Diocese of Sydney HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:-

- 1. This Ordinance shall take effect on the twenty-third day of March 1982.
- The Sydney Diocesan Sickness and Accident Fund shall be managed by Sydney Diocesan Secretariat.
- 3. The Sydney Diocesan Sickness and Accident Ordinance 1969-1981 (which ordinance is hereinafter called the "Principal Ordinance") is amended as follows:-
 - (a) by the omission of the words "and the administration and control thereof by the Sydney Diocesan Superannuation Fund Board" from the preamble thereof, and
 - (b) by the substitution of the following for the definition "Board" in clause 3:" "Board" means
 - (a) prior to the twenty-third day of March 1982 the Board of Directors of the Sydney Diocesan Superannuation Fund as constituted by Ordinance No. 40, 1961, and
 - (b) on and from that date Sydney Diocesan Secretariat."
- 4. The Principal Ordinance is further amended as follows:-
 - (a) by the insertion of "or the Dean of St. Andrew's Cathedral or a Clerk in Holy

 Orders licensed to a clerical office associated with St. Andrew's Cathedral"

 at the end of the definition of "Clergyman" in clause 3, and
 - (b) by the insertion of "and maintain" after "establish" in clause 4, and
 - (c) by the substitution of "its constituting ordinance" for "the Sydney Diocesan Superannuation Fund Ordinance 1961" in clause 5, and

- (d) by the substitution of the following for clause 6:
 "Every clergyman shall furnish to the Board such evidence of his age and such other information regarding himself as the Board may reasonably require" and
- (e) by the omission of clause 9, and
- (f) by the omission of clause 12, and
- (g) by the omission of clause 18, and
- (h) by the insertion of the words "to parishes" after the word "benefits" in the long title, by the substitution of "of" for "for" where firstly appearing in the long title, by the substitution of "parishes" for "clergymen" where firstly appearing in the preamble and by the insertion of "of clergymen" after the word "incapacity" where appearing in the preamble, and
- (i) by the addition of "and St. Andrew's Cathedral" at the end of the definition of "Parish" in clause 3.
- 5. (1) This Ordinance may be cited as "Sydney Diocesan Sickness and Accident Fund Ordinance 1969-1981 Amending Ordinance 1982".
 - (2) The Principal Ordinance, as amended by this ordinance, may be cited as "Sydney Diocesan Sickness and Accident Fund Ordinance 1969-1982".
