## VARIATION OF TRUSTS ORDINANCE 1977

AN ORDINANCE to amend the Sydney Diocesan Sickness and Accident Fund Ordinance 1969-1973 and vary the trusts upon which the Fund thereby constituted will be held.

WHEREAS the Synod of the Diocese of Sydney by the Sydney Diocesan Sickness and Accident Fund Ordinance 1969-1973 has established a Fund known as the Sydney Diocesan Sickness and Accident Fund to provide sickness and accident benefits for clergymen in the Diocese of Sydney <u>AND WHEREAS</u> it has been deemed desirable to make an alteration to the benefits payable from the Fund in certain cases <u>AND WHEREAS</u> by reason of these circumstances which have arisen subsequent to the creation of the trusts on which the said Fund is held it is inexpedient to carry out and observe the same to the extent that they are hereby varied <u>NOW</u> the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod <u>HEREBY ORDAINS DECLARES</u> AND RULES as follows:-

1. (1) The Sydney Diocesan Sickness and Accident Fund Ordinance 1969-1973 is in this Ordinance referred to as the "Principal Ordinance".

(2) This Ordinance may be cited as "Sydney Diocesan Sickness and Accident Fund Variation of Trusts Ordinance 1977".

(3) The Principal Ordinance as amended by this Ordinance may be cited as "Sydney Diocesan Sickness and Accident Fund Ordinance 1969-1977".
2. By reason of circumstances which have arisen subsequent to the creation of the trusts on which the said Fund is held it is inexpedient to carry out the same to the extent to which they are hereby varied.

3. The Principal Ordinance is amended as follows:-

- (a) By omitting in Clause 3 the word "April" and inserting in lieu the word "January".
- (b) By omitting from Clause 7 the whole of paragraph (b).
- (c) By omitting Clause 9 and inserting in lieu the following:-

"9. The determined rate of contribution in

respect of a member shall be payable by the Diocese and shall be payable in equal quarterly instalments on or before the end of the months of March, June, September and December in each Year".

- (d) By omitting in Clause 11 the words "proportion of contributions payable by a Parish" and inserting in lieu the words "determined rate of contribution".
- (e) By omitting in Clause 12 the words "proportion of contributions payable by a Parish" and inserting in lieu the words "determined rate of contribution".
- (f) By omitting from Clause 14(A) paragraph (a)(iii) the words and figures "75% of" where occurring twice.

40 4. The provisions of this Ordinance shall operate from 1st January 1977.
