SYDNEY DIOCESAN SUPERANNUATION FUND ORDINANCE 1961-1981 AMENDING ORDINANCE 1982

No. 56 1982

WHEREAS it is expedient that the provisions of the Sydney

Diocesan Superannuation Fund Ordinance 1961-1981 relating to the

payment of benefits be varied in certain respects.

NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY DECLARES ORDAINS

- (1) This ordinance may be cited as "Sydney Diocesan Superannuation Fund Ordinance 1961-1981 Amending Ordinance 1982".
- (2) The Sydney Diocesan Superannuation Fund Ordinance 1961-1981 is herein referred to as the "Principal Ordinance".
- (3) The Principal Ordinance as amended by this Ordinance may be cited as "Sydney Diocesan Superannuation Fund Ordinance 1961-1982".
- 2. (1) The Principal Ordinance is hereby amended by the substitution of "sub-clauses (cc) and (ccc)" for "sub-clause (cc)" in Clause 21(2).
- 3. The Principal Ordinance is hereby amended by the substitution of ", (c) or (d)" for "or (c)" in paragraph (l) of Clause 27(cc).
- 4. The Principal Ordinance is hereby amended by the insertion of the words "or before" after the word "on" where firstly appearing in paragraph (2) of Clause 27(cc).
- 5. The Principal Ordinance is hereby amended by the insertion of the following sub-clause after sub-clause (cc) of Clause 27:

"(ccc) In the case of member

- (1) who becomes entitled to a benefit under this Ordinance, and
- (2) on or before 1st April, 1962 held a licence or other authority of the Archbishop, and

- (3) is not entitled to an additional benefit under sub-clause (cc),
- an additional benefit shall be paid equal to so much of the additional benefit as would have been payable under sub-clause (cc) of this Clause had:
 - (i) the member been entitled to a benefit under that sub-clause, and
 - (ii) any periods to which Clause 26 may apply been regarded as qualifying service under that subclause,

as the Standing Committee of the Synod considers appropriate in the particular circumstances."

6. The amendments effected by this Ordinance shall be deemed to have taken effect on the 15th day of December 1980.
