These elections will be conducted using an online ballot.

How to vote in the online ballot

On Tuesday 29 September 2020 (being 5 business days from this notice) you will be provided a link by email, allowing you to vote using a secure and anonymous platform (provided by SurveyMonkey). The secure platform –

- allows each Synod member to vote only once in each election
- preserves anonymity of the vote administrators cannot link a ballot to a Synod member, and
- can be accessed by any device with an Internet connection.

The ballot will open on Tuesday 29 September 2020 and close on Wednesday 7 October 2020 at 5:00 pm.

Notices in support of a particular nominee

Synod members may provide a notice in support of a particular nominee in accordance with Regulation 5(b), which will be made available to all Synod members, in accordance with paragraph 5(c)(iii) of the Regulations.

Such a notice is intended to advise other Synod members of the suitability of that nominee, without comparison to any other nominee. Accordingly any notice must be accompanied by written approval from every person referred to in the notice (where reasonable to do so), including any nominee and their nominators, whether referred to by name or not.

The process to provide such a notice is as follows -

- (1) The notice (in Word or PDF form) and written approval from any person (where reasonable) named in the notice, must be provided to the Diocesan Secretary by 5:00 pm Monday 28 September 2020.
- (2) The Diocesan Secretary will publish the notice on an unadvertised but publicly available page on the SDS website, along with a suitable explanation of the origin of the notice.
- (3) A link to the relevant page will be provided to all relevant Synod members along with the link(s) to the online ballots on Tuesday 29 September 2020.
